Project Manager

In the frame of the Green Climate Fund (GCF) preparatory and readiness support, GIZ supports the Thai National Designated Authority (NDA), hosted within the Office of Natural Resources and Environmental Policy and Planning (ONEP), to develop and establish the necessary national structures to engage and access GCF project funds. The first Readiness phase started in early 2017 and will end by mid-2018 and focuses on core GCF procedures and requirements to engage with the Fund. The second phase will start early 2018, in parallel with the current Readiness activities, and will concentrate on private sector engagement, climate finance capacity building and strategic decision-making for (GCF) pipeline development.

The current position encompasses advisory services to the Thai partners (NDA and other key public and private stakeholders) on climate finance and climate policy development, in the context of Thailand's existing climate change frameworks and priorities. The position also includes managerial functions in collaboration with the Project Head.

Responsibilities:

- Support the partners with expertise and advice on climate finance, including mechanisms for the Thai government to work with grant and non-grant financial instruments
- Advise the NDA on private sector engagement and strategic (GCF) project pipeline development
- Lead discussion with Thai political partners on GCF and its latest development regarding key engagement processes and procedures
- Deliver technical inputs and contribute to the organization of workshops and conferences on climate finance and Thailand's engagement with the GCF
- Organize and lead stakeholder meetings between the NDA and (GCF relevant) partners (national, regional as well as key resource persons / bodies within GCF)
- Develop project work plans / strategies and monitoring of project progress
- Supervise and coordinate the service delivery of national subcontractors (technically and contractually)
- Coordinate with other international projects and organizations

We are looking for a candidate who preferably possesses the following experience (or the equivalent of):

- Minimum 7 years of professional working experience in a similar position, working on climate change related issues
- Master degree in finance/business management, environment studies, social/political sciences or any other relevant topic

- Proven experience in climate finance, grant and non-grant financial instruments and private sector engagement
- Previous experience in working in or with Thai government agencies/financial institution
- Experience in project management tasks
- Experience of working in an international context
- Understanding of players and processes in Thailand as well as in international climate politics
- Excellent command of Thai and English in writing and speaking; knowledge of German is an advantage

This will be a fixed-term contract, starting in January and running until December 2019. There is a possibility of continuing beyond this date.
