- Streamline different inputs to formulate DCCE's recommendation.
- Prepare and follow up on the meetings relevant to the climate finance / green economy issue, this includes but not limited to drafting minutes of meetings, letters, and summarize of related materials on the subjects mentioned above, etc.
- Provide DCCE staff with basic understanding of climate finance in form of training, guideline, etc. and conduct work plan on climate finance with the DCCE.

Qualifications:

In the bid, the bidder is required to provide personnel suited to filling the positions described, based on their CVs, the range of tasks involved and the required qualifications. For a shortlisted candidate, GIZ might ask for a short meeting to clarify questions and expectations.
